<b>1.</b>	<p><b>PREAMBLE</b></p> <p><b>Ministry of MSME, Government of India</b> has formulated “<b>Scheme of Fund for Regeneration of Traditional Industries (SFURTI)</b>”, for the development of Village industries in order to organize the traditional industries and artisans for their growth and long-term sustainability. <b>Process and Product Development Centre (PPDC), Agra</b> is the Nodal Agency for the development of clusters under the scheme, undertakes the role of programme fund management, in addition to monitoring and evaluation of project implementation.</p> <p>The scheme specifies the following institutional arrangement at the operational level:</p> <ul style="list-style-type: none"> <li>➤ a Special Purpose Vehicle (SPV) be formed to develop and manage the cluster</li> <li>➤ an Implementing Agency (IA) is appointed to undertake scheme implementation</li> <li>➤ a Technical Agency (TA) is designated to assist and guide the scheme implementation</li> </ul> <p><b>Sathumathurai Palm Leaves Toys and Leather Products Cluster</b> is approved under the scheme. <b>M/s. PanaiOalai UrpathiyalargalKootamaipu, Kaniyambadi</b>, having registered office at Sathumathurai, Vellore Taluk, Vellore District - 623 102, is the Special Purpose Vehicle (SPV) of the Cluster. <b>M/s. TNSRLM</b> is the Implementing agency of the cluster and <b>M/s. The Institute of Entrepreneurship Development (IED)</b> is the designated Technical agency for the cluster.</p> <p>The scheme envisages establishment of upgraded production infrastructure, as the Common Facility Center (CFC), for the manufacturing of handloom products and stipulates the building construction and machinery procurement for the establishment of CFC should adhere the General Financial Rules (GFR) of Government of India.
